There are two main types of real estate closings for purchases of residential properties. One is the traditional closing and the other is an escrow closing. In traditional closing states, like California for example, the buyer and seller and any other interested parties come to the closing table at the appointed time for the transaction, sign all necessary documents and the transaction is completed. The property title changes hands and the money (lender's or buyer's) changes hands as well. In an escrow state, like California for example, all of the stipulations for the transfer of the property and funds are cleared prior to the day of closing. Important documents and funds are held "in escrow" by the assigned escrow agent until the time of the closing. If all stipulations have been met according to the escrow instructions (created between seller, buyer and lender) the closing is final, all funds are disbursed and the sale is final. The closing is generally referred to as an "closing of escrow".



POSTAL FOOD DRIVE

On Saturday May 12, Kiwanis helped the postal service collect canned and dried food for the People for People San Gabriel Food Bank. There were 12 Kiwanians and 12 Key Club members from the high school helping. We took the items (22 carts and 1/2 cart of glass items) to First Baptist church. The carts were 28 in. by 48 in. and 32 in. deep. We delivered 13 carts with canned food items- 9 carts with dried food items and a 1/2 cart full of glass items. 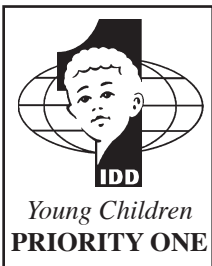
